SOPRAVAP STICK C 15

Description

Self-adhesive membrane composed of elastomer modified bitumen and a composite polyester reinforcement.

Mainly used as a vapour control layer on steel deck and wood constructions.

The upper surface is finished with talcum/sand.

The Self-adhesive overlap and lower surface are protected by a silicone release film.

Pallets may not be placed on to each other during storage and rolls need to be stacked so they won't bend. Direct sunlight and temperatures above +30 °C should be avoided at all times.

Installation

Self-adhesive with self-adhesive side and torched end laps.

The substrate is to be impregnated with ELASTOCOL 503 or ELASTOCOL 600.

In order to obtain a good adhesion, the membrane has to be placed at a temperature above ± 10 °C.

If installation takes place at lower temperatures, the surface has to be heated.

Before processing, the rolls need to be stored for at least 12 hours at a temperature above $+10\ ^{\circ}\text{C}.$
