Description

Membrane composed of flexible PVC and a fiberglass reinforcement coupled on the back (except the overlap) with a fleece.

Used as single layer waterproofing.

The membrane is distinguished by a very high resistance to weathering (UV-rays, ...), humidity, heat and with a high resistance to puncture.

Fully adhered waterproofing system. The fleece on the back can serve as an integrated separation layer. The overlaps need to be welded with hot air.
